CUT TO ALT angle CU as doctor's gloved hand unscrews and removes inner cap and sets it aside on tray, then removes the safety ring, sets it aside and begins to lock the syringe into the port of an IV line.</p> <p>11. CUT TO ECU of doctor's gloved hands locking syringe into IV line. Hands exit frame.</p> <p>12. DISSOLVE TO MCU of doctor's hands entering frame to detach syringe from IV line and recap the syringe by screwing on the inner cap clockwise to reseal the unused medication preserved in the syringe.</p> | <p>Once removed, the MEDGUARDSM cap cannot be replaced.</p> <p>The smaller inner cap unscrews enabling you to remove and discard the safety ring before dispensing the medication.</p> |
